

**Approved Minutes**  
**Little Compton Agricultural Conservancy Trust**  
**Meeting**  
**October 3, 2018**

**1. Call to Order:** The meeting was called to order at 7:00 pm. Members present were B. Richmond, E. Maiato, E. Field, and M. Steers.

**2.) Minutes:**

Minutes from the Public Session September 5, 2018 were reviewed.

**3.) Review of correspondence:**

- Email from Chee Laureanno, dated 9/23/2018, regarding LCAT rate for homes sold below \$350,000.00. C. Cady responded to the email and explain the current tax structure.

- Email from Ed Bowen, dated 9/10/2018, regarding application procedure to lease LCACT properties. B. Richmond explained that LCACT uses a lease process. Properties that are available for lease are advertised in the local paper. Farmers then submit a bid to lease the property.

B.R. discussed exploring the possibility of the fee owners, of LCACT development rights properties, leasing their properties to farmers. If the fee owner is interested, LCACT could be the go-between.

- Email from Christopher Goulart, dated September 19, 2018 regarding Planning Board Agenda and survey.

- Email from Camila Fernandez, dated 9/24/2018, requesting information for audit. To date, Ms. Fernandez has asked for backup information on some transfer tax forms. This has been provided. She has also requested the Master Lands List.

Members reviewed the Master Lands List. This List has had several changes made to it based on review of deeds, Assessors Plat Map and some surveys. This has resulted in a revision of the 2017 land totals and going forth to the 2018 land totals. A Summary of changes has been included with the 2018 Master Lands List. M.S. suggestion adding additional information to included 2017 revised numbers.

**4.) Treasurer's Report**

**-Account Balances**

A narrative report of the accounts, for the period of August 1, 2018 thru August 31, 2018, was received from MaryJane Harrington, Town Treasurer. The report indicates that the beginning balance of all accounts was \$1,858,753.10. Revenues from transfer tax returns and interest totaled \$97,448.40. Expenditures totaled \$13,377.50. The expenditures amount represents regular operating expenses (\$13,777.50) and acquisition costs (0.00). The closing balance for all accounts was \$1,942,864.00.

Currently, the Trust has applications to preserve approximately 227.65 acres of land, estimated to cost, in excess of, \$10 million.

**-Stewardship Committee Update:**

- Stewardship contracted services: Carol Trocki reported monitoring of properties is underway. She is working on the Baseline Documentation Reports for Venusti and Harrison.

- John and June Goulart (Plat 31, Lot 42-1): The repair work on the roadway has been completed.

- Marvell Preserve (Plat 32, Lot 158-3): The SPA held an event on the property this past weekend. Work on the parking has not been completed.

- Wilber, Lint, Loranger (Plat 41, Lot 42-1): No discussion.

- Wislocki (Plat 30, Lot 14-3): B. Richmond and W. Montgomery are meeting with the owner this weekend regarding mowing. The owner has a planting plan she would like to review with B. Richmond.

Marvell (Plat 11, Lot 23-1): The property needs to be mowed and there are some bushes that are growing into the right-of way. These bushes need to be cut.

The Trowbridge property, also located near Warren's Point, was mowed in August. A flower which was in bloom was cut and this upset neighbors. These flowers propagate underground and therefore, will bloom next year. Need to decide when this property should be cut.

Motion to expend an amount not to exceed \$1,000.00 to complete mowing and trimming on Marvell (Plat 11, Lot 23-1) made by E.M. Second by E.F. 6-0 approve

- Lash (Plat 42, Lot 39): The property is located in Bramble Wood. The trees on this property have grown, to a point where they hang over the roadway, when it snows. Residents could have difficulty using the road this winter after a snow storm.
